## NOMINATION FORM

### ELIGIBILITY

- ✓ Nominee must demonstrate outstanding contributions and achievements in **business and community service**.

### NOMINATING PROCEDURE

- ✓ Nominations will be accepted, in proper form, from the membership of the GBRCC, civic organizations, etc.
- ✓ Self-nominations are permitted and encouraged.
- ✓ Current year nominees will be carried over into nomination for the following year, thereby placing the name in nomination for a total of two years.
- ✓ If a nomination is submitted with insufficient supporting information, the person(s) who submitted the name will be notified and asked to submit additional information.

### COMPOSITION OF SELECTION COMMITTEE

- ✓ The selection committee shall be comprised of the current GBRCC President & CEO, Chair of the GBRCC Board of Directors and the current GBRCC professional team.
